#### **ELECTION - NOTIFICATION**

The nominations must be signed by candidate, the proposer and seconder. The last date/ time for receipt of the nomination for Central Executive Committee shall be 22.07.2021 up to 5.00 PM. The detailed election programme is indicted in Annexure-I.
- 5. One member can contest for only one post. He can however, file nomination for more than one post, but then he will have to withdraw his other nomination(s) otherwise all his nominations shall be rejected.
- 6. The candidate, the proposer and the seconder should be valid voters of the Chhattisgarh Vidyut Mandal Abhiyanta Sangh.
- 7. A member who has proposed or seconded any candidate for any post for which only one candidate has to be elected, should not contest and/ or propose or second any other candidate for the same post otherwise the nominations of both or all of such candidates will be rejected.
- 8. The candidate, proposer and seconder must indicate the number of their life membership in the appropriate place of nomination form.
- Incomplete nomination forms shall be rejected. The elections will be conducted by way of secret ballot.
- 10. The nomination forms shall be received by the Chief Election Officer or any of the members of Election Committee as given hereunder on all working days in the office of the Abhiyanta Sangh or their place of posting.
